ORDER :

Government of India in the reference 1st read above, have issued comprehensive guidelines for execution of watershed projects. Para 35.2 (iii) of the Guidelines lays down that not more than 1/4th of IWMP watersheds can be implemented by voluntary organizations. Many of the voluntary organizations working in the sector of watersheds have established high standards of proficiencies and association of such VOs will enrich the implementation of Integrated Watershed Management Programme.

2. Accordingly, the Commissioner, Rural Development, Hyderabad has proposed that involvement of reputed VOs and institutions working for a long time in watershed development would enrich the implementation of watersheds. He has sought approval of Government for involving highly reputed Voluntary Organisations, satisfying the criteria laid down by Government of India, in IWMP watersheds as Project Implementation Agencies (PIAs).

3. Government after careful consideration of the proposal of the Commissioner, Rural Development, Hyderabad hereby approve the proposal of entrusting **(25) IWMP watersheds** sanctioned in 2009-10 to **(12) Voluntary Organizations** as per the annexure enclosed to this order.

4. The Commissioner Rural Development, Hyderabad is directed to enter into a MoU with these VOs clearly laying down the conditions for implementation of watersheds and to issue necessary guidelines indicating the expected annual outcomes etc for assessing their performance every year by the State Level Nodal Agency (SLNA), and also ensure that implementation work on these watersheds begin early.
